<u>The right to rectification - You have the right to request that Our Website correct any</u> <u>information you believe is inaccurate. You also have the right to request Our Website to</u> <u>complete information you believe is incomplete.</u>

<u>The right to erasure — You have the right to request that Our Website erase your personal</u> <u>data, under certain conditions.</u>

<u>The right to restrict processing - You have the right to request that Our Website restrict the processing of your personal data, under certain conditions.</u>

The right to object to processing - You have the right to object to Our Website's processing of your personal data, under certain conditions.

<u>The right to data portability - You have the right to request that Our Website transfer the</u> <u>data that we have collected to another organization, or directly to you, under certain</u> <u>conditions.</u>
